# **WHOLESALE AGREEMENT**

## **GENERAL TERMS OF AGREEMENT**

To qualify for wholesale purchases, you must be a valid retail business and by agreeing to our terms and conditions you certify that you are such.

## **ORDER REQUIREMENTS**

We ask that you order a minimum of 12 bottles of **The Confidence Pill** with each order.

Due to limited stock, we ask that you not order more than 200 bottles (without one week prior notice), in order to better coordinate things with our production and shipping deadlines.

## **PAYMENT INFORMATION**

We accept payments via **PayPal**, only.

The first three orders needs to be paid as such: Once your order is confirmed, \$75 of the total amount of the order [which includes product cost, 3.5% PayPal fee, and in some cases shipping and insurance charges) needs to be paid up front, via PayPal, before the order is shipped, and the balance of order payable in 30 days, maximum.

After the first three orders, all subsequent orders will be Net 30.

Also, as far as shipping charges goes: we never mark up shipping charges to you. Whatever it costs to ship the product to you, is all you pay, and not a penny more.

After your order is confirmed, we will email you an invoice and the goods will be held for up to 4 days pending your initial, partial payment of \$75.

Please note that we hold limited stock, so all orders will be held for a maximum of 4 days before being reallocated to our stock list. No orders will be processed until the initial, partial payment of \$75 is received.

Orders must be paid in full within 30 days of receipt of your order. Failure to meet this deadline will incur an additional cost of 5% of the total order for each week of delay, unless otherwise stated. We reserve the right to alter our prices at any time, unless prior invoiced.

If, for example, a retailer sold one 180-count bottle of **The Confidence Pill**, which contains an extra **180 FREE pellets** (or 360 pellets total), at \$19.95, the customer would be saving themselves \*\$48.90 off of the MSRP.

\*Explanation: Each bottle of **180** pellets is currently being sold on MyWorstFears.com website for \$29.95 plus \$8.95 S&H. If you add in the value of the extra 180 free pellets or \$29.95, the total savings to the customer is: \$29.95 (for 180 pellets) + \$8.95 (S&H) + \$29.95 (for an extra 180 pellets) = \$68.85. Then, take \$68.85 minus \$19.95 (final cost to consumer) = \$48.90 savings for the consumer.

## **SHIPPING & HANDLING**

Where applicable, the retailer will incur the shipping and insurance costs. Orders are typically sent out within 2-3 business days of placing the order. We can use USPS, FedEx, DHL, or UPS Ground, for shipping, based on the retailer's choice or cost affordability... that is, when the retailer is paying for the shipping costs.

When Myworstfears.com is paying for the shipping costs, USPS will be used.

If your shipment is damaged in transit you agree to contact MyWorstFears.com maximum, 1 day after date of delivery, via email. MyWorstFears.com will issue retailer a return authorization number in order to return the damaged, in-transit goods.

Goods can be marked-up to \$29.95 per bottle of 180 or 360 pellets, without written consent of MyWorstFears.com.
